Susan Gilbertz called the meeting to order at 3:39 p.m. in the Chancellor's Conference Room.

Dr. Gilbertz noted this is Dr. Nook's last meeting as our Chancellor. The Senate thanked Dr. Nook for his excellent relationship with the Senate, and wished him well. The Senate also welcomed Dr. Ron Larsen, new Interim Chancellor.

The minutes of December 1 were accepted as presented.

I. CHANCELLOR REPORT

Dr. Nook noted that the Commissioner's Office has decided to change how budgets are allocated. In the past, budgets were allocated to the flagships (Missoula and Bozeman), and those units were responsible for assigning budgets to the units under them. Now, the Commissioner will be doing all of the allocations to each unit. It's unknown how this will shake out for us.

II. PROVOST REPORT

Provost Hoar thanked everyone for participating in the Gardner event this past Tuesday. It was a great discussion of how our initiatives have evolved since last August. There is still some funding for one-time projects, so rather than putting out a call for proposals, Dr. Hoar has decided to just ask for faculty to come forward with ideas. He and Vice Chancellor for Student Affairs Joe Oravecz will have an open meeting time every Monday, 11:30 a.m. to 1:00 p.m. in the CCR, to hear these ideas. Appointments are not necessary.

III. OTHER REPORTS

Jim Barron, Co-Chair of the Gen Ed Committee, reported that evidently there is word around campus that the GEC will be changing Gen Ed, but that is not necessarily the case. The committee has been researching our peer institutions' Gen Ed programs, and they are also sending committee members to conferences on ePorfolios and assessment. They hope to bring a proposal this semester for a portfolio assessment of Gen Ed which will be beyond the testing we are trying to do now.

V. ITEMS – FIRST READING

Tabled at 10/20/16 Senate

Item 10 Recommendation from the Gen Ed Committee Regarding Gen Ed Assessment.

Dr. Barron stated that the Senate needs to make a decision now, so we can get rolling on this project. Right now we are not assessing Gen Ed, and that needs to change. Many have said that Gen Ed is broken, but we don't know how it is broken because we have no data. The goal of the Proficiency Profile test by ETS is to assess most of the Gen Ed outcomes. The GEC has struggled to get more than a tiny sample of students to take the Proficiency Profile; requiring it is the only way to get an acceptable sample size. In order to require the test of all students, we have to get it in the catalog. How students will know about the requirement, when they will take the test, and how the test will be administered are yet to be decided. The GEC is asking for the Senate's trust that those details will be worked out.

It was noted that, as an incentive, we could offer to refund the student's graduation fee if they take the test. Vice Provost Matt Redinger stated that there is funding for incentives in the assessment budget.

The question was raised as to whether students will know their scores. Dr. Barron stated that students can get their results, but it's not yet been decided if all results will be sent to students, or if they will only be provided to those students who ask.

It was cited that all the elementary education majors are required to take the PRAXIS test, also by ETS. Those students also don't have much time and are often far from campus in their final semester as they student teach. Why not use the PRAXIS test in place of the Proficiency Profile for those students? It was responded that it would be difficult to compare this subset of students to the rest. Also, students must pay for their PRAXIS test, but the assessment budget will pay for the Proficiency Profile test.

It was noted that we have a large number of students who may start at MSUB but don't finish, either transferring or dropping out. Our data will automatically be misleading since the unskilled students are taking themselves out of the equation. Dr. Barron responded that at this time, we are not pre- and post-testing our students. Students will only take one test and they are compared to similar, master's-granting institutions across the country. It was suggested that we only compare our data to our "peer institutions" that the Chancellor often references, and we should have our sociologists take a look at the tests.

It was suggested that the plan for this requirement needs to be carefully thought out, because the worst thing we can do is hold back a student who has finished the degree but cannot graduate because of this test. We should be able to set up something that indicates when students have completed Gen Ed, so they can take the test at that time, whether they are seniors or not.

Suzette Nynas, Director of the Athletic Training program, noted that this new program will be a five year program that earns the student a bachelor's and a master's degree. Due to changes with the accrediting body, all athletic training programs must move to the master's level, so there will be significantly increased competition for those students. This is an effort to entice students into a time- and money-saving program. We also have an articulation agreement with Rocky Mountain College.

It was noted that these courses are 9 credits each, and they are specifically offered only in the summer for teachers who wish to teach dual credit courses. The Board of Regents policy states that the teacher must have a master's degree and at least 9 credits in the subject area (or a plan to earn those credits) to teach dual credit courses. Kevin Nemeth, Director of Extended Campus, noted that a grant is paying for 35 teachers to take these courses. Next year the courses will be offered at self-supporting rates.
