VI. DISCUSSION/ACTION ITEMS

A. Senator Responsibilities Draft

It was noted that this list of responsibilities will be added to the form faculty fill out to run for Senate. It should also be noted in the responsibilities that Senate meets on Thursdays at 3:40 p.m.

It was agreed it will not be added to the bylaws, requiring an all faculty vote, but rather considered as a resolution.

VII. NEW BUSINESS

Recently in the news, new artificial intelligence chat bot ChatGPT was announced to be able to write entirely new, non-plagiarized essays. It is now indistinguishable from human writing. SAT scores on essays written by ChatGPT are medium to high. There are now students fighting campus policies—and winning—saying that AI is not cheating,

but rather a time saver, and AI is not specified in plagiarism policies. We should make sure our policies are up to date. It was suggested that the Center for Teaching and Learning could do a workshop on AI.

It was suggested that the ChatGPT issue should be brought up at the All Faculty meeting to be held later this semester.

It was noted that how we communicate to our students matters here. Many students using ChatGPT are doing it because they are overwhelmed and out of time on an assignment. Faculty can grant the student an extension rather than the student cheating.

It was noted that there is no campus-wide procedure preventing cheating specifically in online courses. There are ever more ways to cheat in an online course, and methods vary as widely as disciplines. One campus policy would need to include a whole array of cheating methods.

It was agreed that the Senate needs to learn more about these issues. A subcommittee was formed to discuss what we know and what we don't know, the challenges with cheating and today's technology, what other universities are doing, what tools are available, etc. The members of the subcommittee are Rachel Waller, who will chair, and Scott Butterfield and John Pannell. They may also ask a member of the IT staff. The committee will have a chance to report at each upcoming Senate meeting.
