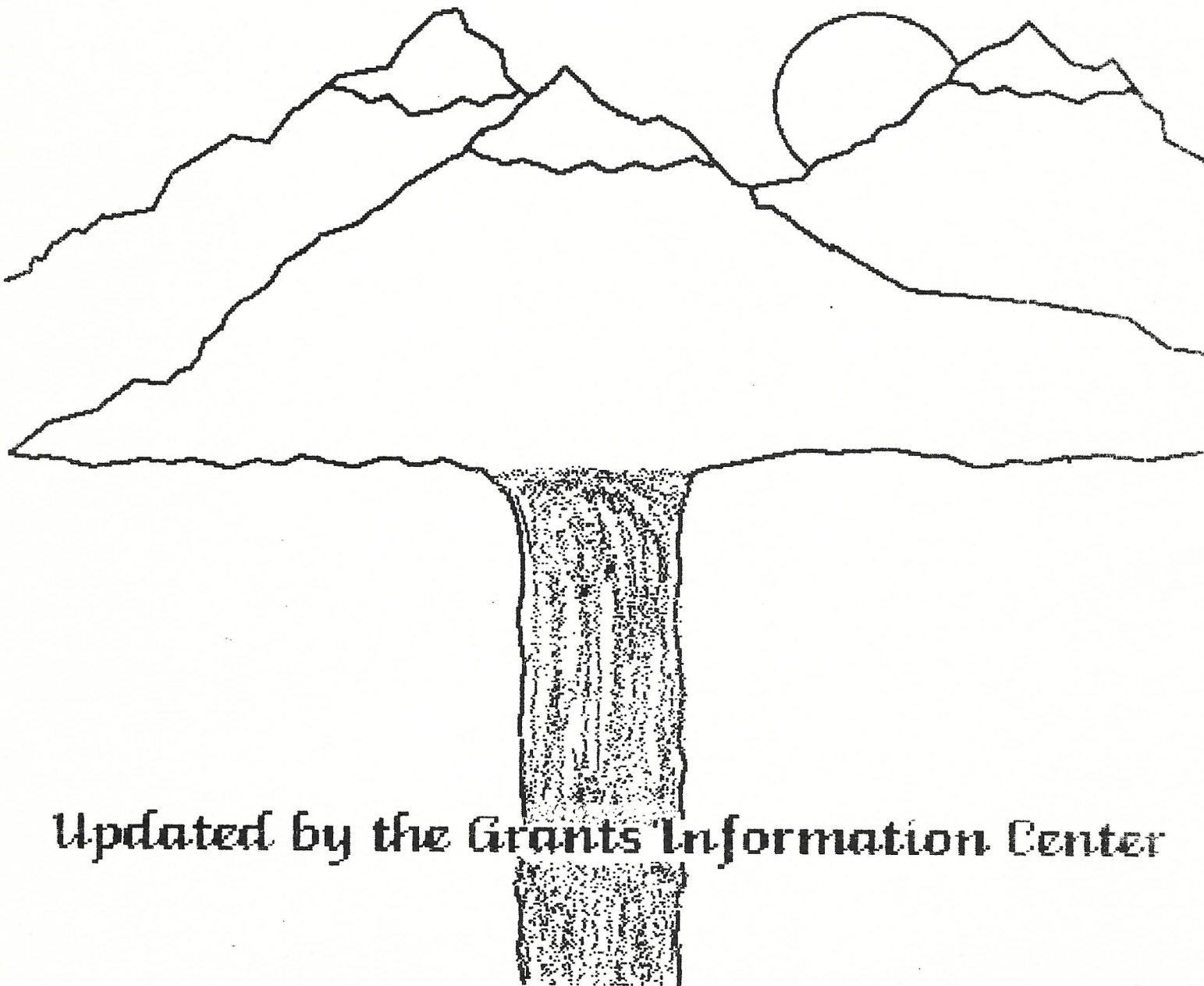

INTRODUCTION

The Directory of Montana and Wyoming Foundations is edited and published by the Grants Information Center at Eastern Montana College. The Grants Information Center is housed in the library on the EMC campus. This collection is one of two such collections in Montana* and is part of an extensive nation wide network of Cooperating Collection Libraries. Much of the material in these centers is provided in an up to date basis by the Foundation Center; a national service organization, with main offices in New York and Washington D.C., and supported solely by the foundations. The existence of this national network enables the individual Cooperating Collection Libraries to provide access to reference materials containing information on the location, limitations, eligibility requirements, history, and giving trends of funding sources. Furthermore, each center has on hand a variety of resources that include examples, guidelines and helpful hints on how to develop a successful proposal. Our purpose in producing this directory is to assist individuals and organizations in Montana and Wyoming who are looking for funding for special projects or to aid in the continuation of ongoing services. It is our experience that many of the services and special projects funded in the Montana & Wyoming area benefit residents of both states. Therefore, we have made an attempt to include all of the foundations in these states, realizing that some foundations for various reasons have not been included. Although, this Directory provided information on local foundations your organization may find it worth-while to look for funding from national sources as well. It is our hope that by providing this information the number of requests to foundations for funding in areas outside their areas of interest will be reduced. Submitting requests to foundations that have interest in the area established in your proposal will save time and effort for the foundation as well as your organization.

Because the Montana Arts Council and the Montana Committee for the Humanities provide funding for a wide variety of projects in the area of the arts and humanities we have included these organizations in the Directory.

The Montana Arts Council provides funding to organizations which are chartered in Montana as non-profit Federal Tax exempt organizations. Grant funds must be matched by cash or in-kind contributions; therefore, the Council will not fund more the 50% of total cost. Also, the fund cannot be matched with other Federal funds.

In-kind contributions are services and other materials donated to an organization. They are defined as contributed supplies or services at the fair market value, those necessary to carry out grant programs and those which are essential to the completion of the program and will be utilized during the project. The sub-grantee must maintain documentation of in-kind contributions.

Council Priorities:

1. Programs must be in existence for at least one year as a tax-exempt organization to be eligible.
2. Gives priority to Montana citizens
3. The Council places a high priority on those projects

that would reach special audiences comprised of citizens who are not regularly serviced by the arts. These include the handicapped, elderly, lower income groups, institutionalized, ethnic and racial minorities and residents of smaller rural communities.

4. The Council will support college projects if they are determined to be of benefit to the general public.

Low Priorities:

Funding of scholarships and projects offering free art.

Areas Not Funded:

Permanent equipment, reducing existing deficits, and individuals.

Application Process:

1. Supply a copy of Internal Revenue Service Tax-Exempt Form 501(c)(3) non-profit determination.

2. Have the formal approval of the program's Board of Directors to submit the application.

The Montana Committee for the Humanities is a non-profit organization which operates under a grant from the National Endowment for the Humanities, a Federal agency. The term humanities includes but is not limited to : history, philosophy, languages, linguistics, literature, archaeology, jurisprudence, history and criticism of the arts, ethics, comparative religion, and those aspects of the social sciences employing the historical or philosophical approaches. The Montana Committee for the Humanities has the primary goal of stimulating dialogue between the adult public and humanity scholars.

Eligibility:

A non-profit group, institution, or organization in Montana may apply. These may include: citizen's groups, church groups, colleges, professional associations, etc. Cosponsoring between one or more non-profit organizations is encouraged. Individuals are not eligible.

Format:

No limit on format. The Committee encourages new approaches and ideas for projects which meet the grant criteria.

Restrictions:

The Montana Committee for the Humanities cannot support:

-Private research, scholarship, fellowships, cost of writing or production or publication of books or journals.

-Projects which focus on personal instead of public concern.

-Annual meeting or organizations.

-Construction or restoration costs, or the operating expenses of existing organizations.

-Equipment, property, or other capital purchases.

-Museum or library acquisitions.

-Direct social action or planning for direct action, or projects which advocate a particular course of action.

-Meals or refreshments for audiences.

-Course for credit.

Deadlines:

Proposals should be submitted with 18 copies. Grant applications for less than \$10,000 are considered an a

monthly basis and applications must be submitted by the 20th of any month. Applications for \$10,000 or more are considered quarterly.

Assistance is Available:

Committee members welcome the opportunity to answer and discuss program ideas. They are also happy to review rough drafts of proposals. Persons planning to submit a grant application are urged to contact the staff before submitting a final proposal.

THE SEARCH FOR GRANTS

Locating Funding sources

1. Develop a list of prospects:

A. Create a list of words or phrases that describe the different aspects of your project. NOTE: KEEP THIS LIST AS BROAD AS POSSIBLE (TO START WITH) IN ORDER TO GAIN EVERY POSSIBLE ANGLE OF APPROACH.

B. Use "subject (or field of interest) indexes" to look up foundations that have interest in the different areas covered by your project. NOTE: AVAILABLE REFERENCE BOOKS THAT CONTAIN SUBJECT INDEXES:

1. Foundation Directory
2. Corporate Foundation Profiles
3. Corporate 500
4. The Grants Register
5. The Foundation Centers' Comsearch Broad
Topic Publications

C. Further Qualifying Sources:

1. Individual entries will list specific guidelines and requirements.
2. Eliminate foundations that do not qualify.

NOTE: DO NOT LET A GRANT CONTROL YOUR PROJECT. ELIMINATE FOUNDATIONS THAT DO NOT FALL WITHIN YOUR OWN PROJECT GUIDELINES RATHER THAN CHANGING YOUR PROJECT TO FIT WITHIN THE FOUNDATION QUALIFICATION GUIDELINES.

2. Background Research:

Consider which of the foundations left on your list most clearly match your needs by researching the foundations giving trends paying particular attention to:

1. Subject interest—what types of projects has the foundation funded in the past?
2. Type of recipient—what types of organizations has the foundation funded in the past?
3. Type of support—does the foundation give matching funds, building funds, or continued support monies?
4. Geographic preferences—in what areas of the country will foundations give?
5. Range of giving—what size of grants does the foundation make?
6. Application deadline—when must an application be made?

NOTE: THIS INFORMATION CAN BE FOUND BY USING THE
FOLLOWING SOURCES:

1. Source Book Profiles--an in depth review of the 1,000 largest foundations.
2. Annual Reports-- a report published by the foundation.(about 500 foundations provide them)
3. Tax forms (990 AR & PF)--annual tax forms filed by each foundation specifically listing its giving records for the year.

PROPOSAL WRITING OUTLINE

Summary:

Clearly and concisely summarize the request. Although this is an overview of the proposal it should include a specific statement of what it is you are requesting.

Introduction:

Describe your agency's qualifications and/or credibility. Include past success in special projects and grant funding the agency has previously received from other sources.

Need Assessment:

In this section address the need or the reason for your project. Show the existence of the need for your project to be carried out. Use statistics, letters from community leaders or other agencies, etc.

Objectives:

Describe exactly what it is that you expect to accomplish. Clearly outline the goals of the project or those things that will be done with the grant money.

Methods:

The activities that will directly lead to the

accomplishment of the project goals. Define the means to the end, or the ways in which your organization will go about reaching its stated objectives.

Evaluation:

This section contains the plan for determining the degree to which the project objectives have been met. This plan should be detailed and precise yet at the same time it should remain a simple and clear tool by which success can easily be measured.

Future:

Briefly outline a plan of continuation beyond the time of the grant period. Although brief this section can show the funding source that the impact of the grant money will be felt beyond the grant period, even if the project is a one time event.

Budget:

The purpose of this section is to give a detailed account of the costs to be incurred throughout the project by your organization. Include in this section costs to be met by other funding sources. Also include items that could be listed as matching funds and volunteer. Finally, it is helpful to remember that in the long run honest will pay off.

**SOME BASIC PRINCIPLES
OF PROPOSAL WRITING**

1. The proposal should be neat, clean and easy to read!

There should be no typographical errors in your final copy. Send an original, with copies only if the funding source requests them. Don't send more than one copy unless you're asked. Break up the copy nobody wants to look at a proposal that starts at the top of one page and goes on interminably, unbroken by paragraphs or some other breathing space.

Don't use extravagant proposal packaging. Spiral bindings were made to be cut apart, and expensive covers suggests that you waste money. If you employ a very unusual format, perhaps to attract attention, you risk focusing too much attention on the form of your proposal, instead of its content. If you depart from the norm, you had better do it well. One applicant sent out 1,000 proposals, printed in question-and-answer format with questions in blue and answers in red, and received not a single response. Most recipients probably thought the letter was intended for the Bicentennial Commission.

2. Write your proposal in English.

Proposal writing is not an opportunity to demonstrate your mastery of bureaucratize. Even when your funding source employs jargon in its guidelines, use it only if you feel you

must, and define your own terms. Each of five panelists reviewing applications in "career education" may have his or her own understanding of what it is; tell them what you think it is.

To test the clarity of your writing, have friends or family read your proposal. Some of your best comments will come from people unfamiliar with your field, not operating on the same assumptions as you, and unfamiliar with your jargon. Merely passing a proposal around your agency has limitations. Staff may think they know what you mean, or may be less critical because of your role (or theirs).

3. Make it brief.

What is the proper length for a proposal? Just long enough for you to clearly communicate your message, but not long enough to produce a stupor. A ten-page proposal can leave readers hungering for more; a two-page proposal can still put them to sleep.

4. Be positive.

Get yourself "up" for the proposal-writing experience. Remember that you are offering the funding source an opportunity to participate in an important, useful activity. Writing for grant support is not like writing home for college money. You don't have to apologize. You're an applicant, not a supplicant! Don't beg! Remember that the funding source gets its credibility from funding winners; not

losers. Few grant-making agencies want to provide you with your last grant on the road to oblivion.

Don't call attention to your mistakes. The funding source will learn about them soon enough, hopefully in discussion where you can give more information. Don't say something like:

"We are sure that you are aware of the sudden departure of our fiscal officer some three years ago, and the subsequent investigation of this agency by the General Accounting Office. We have made great strides since that time, have replaced several members of our board of directors, and have employed a former GSA official to oversee our fiscal matters.

5. Avoid unsupported assumptions.

The astute reader finds any number of unsupported assumptions in most grant applications. These fall into a variety of categories:

- * The funding source is told nothing about the applicant because the grant seeker is sure that the funding source knows all about them.
- * The national scope of a problem is described, but there is not documentation of its existence in the community served by the grant seeker.
- * A casual relationship between events is presumed, but no evidence of cause and effect is presented.

The assumptions that find their way into proposals are

limitless. Sometimes the applicant leads into an assumption by saying "we believe." Supporting "beliefs" with evidence and documentation is a check on logic, produces a more coherent proposal, and demonstrates your expertise to the funding source. Present enough evidence to support your position, and no more. Don't overkill! Pages of tables, charts, and graphs will probably not be read, and too often fail to support the thesis of the proposal writer. Cite sources of data in the body of the proposal and avoid footnotes. Don't develop a doctoral dissertation.

our staff will be in New York City during the early part of the next month and would like to meet with you at your convenience."

A cover letter may seem like a simple proposition, but there are a few things to look out for:

Don't tell the reader that they should fund your proposal, such as: "We know that you will find this proposal to be of the greatest significance," or "surely it is obvious that..."

Conversely, don't get on your knees, and sign off the cover letter "with a wing and a prayer" or "supplicatingly yours."

Address your letter to a specific person at the funding source. Make sure you know who the right person is including that persons official title if applicable. Proper spelling of his/her name is important. Make sure he/she is still alive, and never send the proposal "To whom it may concern" or "Gentlepersons."

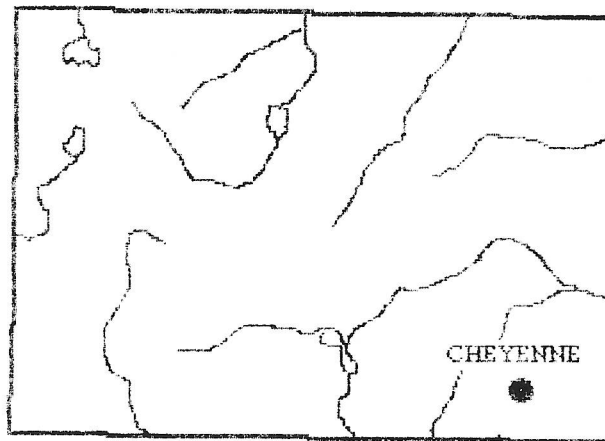
