# Introduction

This directory of foundations active in Montana is compiled and published by the Grants Information Collection staff at Montana State University - Billings. The collection is housed in the library on the MSU-B campus and is one of three such collections in Montana libraries, all members of The Foundation Center cooperating collections network. The other collections are located in Helena at the Montana State Library (phone: 1-800-338-5087) and in Bozeman at Bozeman Public Library (phone: number 406-586-4787). It is generally appropriate to call ahead for hours of collection availability.

Much of the material in these collections is provided by The Foundation Center, a national service organization, supported solely by foundation funding, with main offices in New York. The Foundation Center Library is located at 79 5th Ave. New York, 10003-3076. Their phone number is 212-620-4230.

The Foundation Center has recently published its *User-Friendly Guide: Grantseeker's Guide to Resources (Revised Edition 1994)* which we would be happy to send to you (fourteen dollars, postage included). It includes information on sources of corporate and government funding, grants for individuals, types of foundations, and, especially helpful, instructions in the use of Foundation Center materials. The Montana Arts Council provides funding to organizations which are chartered in Montana as non-profit tax exempt organizations. Grant funds must be matched by cash or in-kind contributions; therefore, the Council will not fund more than 50% of total cost. The match money cannot come from federal funds.

In-kind contributions are services and other materials donated by an organization. They are defined as contributed supplies or services at fair market value, those necessary to carry out grant programs and those which are essential to the completion of the program, to be utilized during the project. The sub-grantee must maintain documentation of in-kind contributions

## **Council Priorities:**

1. Programs must be in existence for at least one year with tax-exempt status to be eligible;
2. Give priority to Montana citizens.
3. The Council places a high priority on those projects that would reach special audiences comprised of citizens who are not regularly served by the arts, e.g. the handicapped, elderly, low income groups, institutionalized, ethnic and racial minorities, and residents of small, rural communities.
4. The Council will support college projects if they are determined to be of benefit to the general public.

## **Low Priorities:**

Funding of Scholarships and projects offering free art

## **Areas Not Funded:**

Permanent equipment, reducing existing deficits and individuals.

## **Application Process:**

1. Supply a copy of Tax Exempt form 501(c)(3), non-profit status.
2. Have the formal approval of the program's Board of Directors to submit the application.

## **Cultural and Aesthetic Project Grants:**

*Deadline:* August 1, 1995

*Grant period:* July 1, 1995 - June 30, 1997.

## **Who is eligible?**

- Any person, association or representative of a governing unit, such as, a Montana state, regional, county, city, town or tribal government. Governing units usually apply on behalf of non-profit, tax-exempt organizations which will conduct the project.

## **What projects are eligible?**

- Grant applications must be for cultural and aesthetic projects, including but not limited to the visual, performing, literary and media arts, history, archaeology, folklore, archives, collections, research, historic preservation and the construction or renovation of cultural facilities.

## **How are Grants Reviewed and Awarded?**

Prior to each two-year grant period, a sixteen-person advisory committee reviews all applications and makes funding recommendations to the Montana Legislature which awards the grant. The members of this committee are appointed equally by the Montana

Arts Council and the Montana Historical Society. The grant process is administered by the Montana Arts Council.

## How does my organization apply?

An instruction booklet and application form will be mailed to you. The deadline for receipt of completed applications is **August 1st**. Applications on behalf of private museums, art centers and cultural facilities *which have received a Cultural and Aesthetic Grant in the past*, must receive county or municipal **financial or in-kind** support to be eligible for funds.

- **Special Project Grants** are for specific activities, services or events of limited duration, the expansion of on-going programs to meet defined needs and to support projects which generate new sources of revenue. A **Short application form** for grant requests of \$4,500 or less is available. Organizations with little grant writing and management experience might consider submitting applications in this category.
- **Operational Support Grants** are for cultural organizations which have been in existence for at least two years. Grants should not reduce the applicant's fundraising efforts or support program expansion beyond an inflationary increase. *Applications which may be considered include:*
  1. Emerging cultural organizations which are in the early stages of development, i.e., formally organized for at least two years with an on-going program and generally with paid professional staff.
  2. Organizations with unusually high expenses without a local funding base.
  3. Organizations established to serve the entire state or a significant sub-state base.
  4. Well-managed and established organizations confronting unforeseen emergency situations.
  5. Organizations which are recognized as essential to Montana's cultural life because of their excellence of programming and longevity of service.
  6. Organizations which provide a high ratio of cash match to their grant request.

**Matching Requirements:** Each grant dollar generally must be matched with one dollar in cash or in-kind goods and services.
- **Capital Expenditure Grants** are for additions to a collection or acquisition of works of art, artifacts or historical documents; historic preservation, and the renovation or construction of cultural facilities. Projects which affect historic or prehistoric properties must consult the State Historic Preservation Office.  
**Matching Requirements:** Each grant dollar generally must be matched with three dollars in cash or in-kind goods and services.
- **Challenge Grants** are for the creation or expansion of permanent endowments to support non-profit cultural organizations and activities. Organizations applying in this program must contact Council staff.  
**Matching Requirements:** Each grant dollar must be matched with three dollars in:
  - Cash (minimum of one-third of the total match).
  - Irrevocable planned or deferred gifts or
  - Life insurance, devises and bequests (maximum of one-third of the total match)

The Montana Committee for the Humanities is a non-profit educational organization which operates under a grant from the National Endowment for the Humanities, a federal agency., with state coal tax funds, and the gifts of generous private and corporate donors. The term 'humanities' includes, but is not limited to: history, philosophy, languages, linguistics, literature, archaeology, jurisprudence, history and criticism of the arts, ethics, comparative religion, minority studies, and those aspects of the social sciences employing historical or philosophical approaches. The Montana Committee for the Humanities has the primary goal of stimulating dialogue between the adult public and humanities scholars.

## **Eligibility:**

A non-profit group, institution, or organization in Montana may apply. These may include citizen's groups, colleges, professional associations, etc. Co-sponsorship between one or more non-profit organizations is encouraged. Individuals not eligible.

## **Format:**

No limit on format. Programs for tribal groups, schools, teachers and the general public range from workshops, conferences and seminars to year long residences, radio, television and film. The Committee encourages new approaches and ideas for projects which meet the grant criteria.

## **Restrictions:**

The Montana Committee for the Humanities cannot support: scholarships, fellowships, cost of writing or production of publications or books or journals; Projects which focus on personal instead of public concerns; construction or restoration costs, or the operating expenses of existing organizations; equipment, property, or other capital purchases; Museums or library acquisitions; direct social action or planning for direct action or projects which advocate a particular course of action; meals or refreshments for audiences; courses for credit.

**Application:**

Write for application forms and information. Proposals should be submitted with 25 copies. Grant applications for \$3000 or less are considered on a monthly basis and applications must be submitted by the 20th of any month. Applications for more than \$3000 are considered quarterly. Immediate action grants of \$500 or less are available at anytime. Media production applications are reviewed only once a year.

**Assistance is Available:**

Committee staff and members welcome the opportunity to answer your questions and discuss program ideas. They are also happy to review rough drafts of proposals. Persons planning to submit a grant application are urged to contact the staff before submitting a final proposal.


