III. PROVOST REPORT

Copyright issues with online courses

Interim Vice Provost Matt Redinger stated that the Commissioner established a committee, with several MSUB faculty and staff, to tackle this issue. Eventually the move was made to adopt the MSU-Bozeman policy, which conflicts with BOR policy, so the issue was put on the BOR agenda. However, it was then pulled off the BOR agenda because more faculty input was apparently needed. Currently, the issue is not on the BOR agenda.

IV. DISCUSSION/ACTION ITEMS

A. Possible Loss of Men's Faculty Locker Room in P.E. Building

It was noted that the Space Utilization Committee recommended that we move ahead with reassignment of the space. This is not an academic issue and not the purview of the Senate.

B. High Cost of Summer (Onsite) Courses

It was stated that Environmental Studies students have a required course, taught by the History Department, that is only offered in summer. Taking just that one course in summer costs students about \$900. The History Department is short-handed at this time and they cannot currently work the course into their fall/spring schedules. Dean Tasneem Khaleel stated she would work with the departments to find a solution.

C. Student Drop Data

Interim Vice Provost Redinger stated that Admissions & Records does collect data when a student drops. They have a mountain of anecdotal evidence, which won't surprise any of us. Students drop because of a sick mother, work schedule changes, job loss, and the like. It was noted that the BOR may decide to take punitive action against units with higher drop rates. We may need data from Admissions to help explain why students drop.

D. The Flat Spot (12-18 credits)

Our flat spot was decided by our former Chancellor. Bozeman currently calls a full-load anything over 12 credits, with no upper limit. It was cited that with the BOR interest in shortening time to degree, students may want to register for more than 18 credits a semester.
