Susan Gilbertz called the meeting to order at 3:40 p.m. in the City College Health Science North Conference Room.

# III. OTHER REPORTS

Vice Provost Matt Redinger noted that, as we approach our deadline for the NWCCU accreditation report, we had to get administrative officer reviews done. In the past, the data from the many parties involved in an administrator evaluation was put together by the Center for Applied Economic Research, but since the Center is no more, and we had leadership turnover in the last few years, the evaluations were not getting done. FutureSYNC International, which also generated the Jacket Proud initiative, had an existing administrator evaluation process, so we used it because we are up against the NWCCU report deadline. We are now aware that faculty were not adequately represented, especially in the Dean reviews. We need to work together to find a way to evaluate our administrators that involves faculty, but we also need to move away from the extremely time-consuming processes used in the past. It was noted that so few faculty were involved in the most recent evaluations, the validity of the results could be called into question. It was cited that although it would be excellent to survey all faculty involved for each evaluation, the security and confidentiality of the data, as well as the huge amount of data processing are really the issues. Vice Provost Redinger will return to report on steps toward a more inclusive process in the future.

# IV. DISCUSSION/ACTION ITEMS

# A. Dual Enrollment: Oversight and Assessment

Guests: Kevin Nemeth, Director of Extended Campus & Harold Olson, Coordinator for Dual Enrollment

The question had been raised as to whether there is any oversight of the delivery of MSUB courses in the high schools. Vice Provost Redinger noted that just last weekend, they held a mini-conference where the high school teachers participating in the program met with their MSUB mentors to discuss how the courses were working. It was an overwhelmingly positive experience, and they are now planning to hold this conference at least once a year, if not more often.

Mr. Olson noted that when a high school teacher expresses interest in teaching a Dual Enrollment course, the first thing is getting that teacher's credentials to the MSUB department and mentor. If the Department is not agreeable to having that person teach, we don't move forward. However, if all parties are in agreement, the curriculum is then examined for gaps to match the high school course as close as possible with the college requirements. The mini-conference was very successful in generating networking opportunities, and did have some grant funding to get it rolling. They are now talking about City College instructors doing an in-service with teachers at the Career Center.

The Dual Enrollment program is growing, as dual credit is across the nation, and we are taking it one step at a time. Hopefully enough structures and procedures are in place that even if Mr. Olson is gone, the program will carry on. It was noted that these teachers are probably getting more supervision than part-time faculty on campus.

It was cited that part of the mentor's responsibility is to follow up with the mentee. It was noted that the best assessment of the students' learning will be their level of success in their next course. Mr. Nemeth noted that we are aligning our process with a national accrediting body to ensure rigor in the courses.

Victor White, Radiologic Technology, noted that there is great demand in the area for ultrasound technicians. City College is starting with just the general certificate, but hope to expand into specialized areas soon. This Certificate program will be geared toward people already in the healthcare field. Lonnie Schrag, Chair of Nursing, Health and Safety, noted that this will be the only ultrasound program in the state—the nearest program is Cheyenne, Wyoming. Mr. White noted that each Billings hospital can only take two students, so they will be working with other regional hospitals to expand clinical

space. The clinical can be set up anywhere there is a qualified instructor, so this program is not just available in the Billings area. City College will have to hire one part-time faculty member to help cover the Radiology Tech program as Mr. White moves to teach these new courses.

# A. Library Committee: Purpose, Size, Placement of Junior Faculty

Guest: Darlene Hert, Director, Library

Ms. Hert noted that the Library Committee bylaws are very outdated. For instance, they still list the Director as Library and Audio-Visual Services, which haven't been in the Library for ten years. She would like to see the committee members as champions for the Library. The current librarians are now serving as Library Liaisons, and these people are there to work with faculty on what kind of resources the Library can procure for classes. The Library is also part of the TRAILS consortium of 24 academic libraries, who can work together to secure reduced prices for databases, streaming services, and other options. The biggest thing the committee can do is help communication with the faculty on how the Library can help.

It was suggested that the Library Committee be disbanded and instead, a liaison be selected from each department to work with the Library on a regular basis to enhance communication. Ms. Hert agreed that this proposal would work well.

⇒ Motion by Kelly Shumway, seconded by Cindy Dell to **remove the Library** Committee from the Senate bylaws, notify the current members and thank them for their service, and add the Director of the Library as an ex-officio member of the Senate.

Ms. Hert will create a letter to be sent to the current Library Committee members, thanking them for their service.

# C. New Textbook Ordering Process

We are moving toward no textbooks in the campus bookstore, and instead using a website buyer. If we sign on with them, they guarantee the books will arrive on time, assuming students order in time. However, if financial aid has not arrived in time, our book loan program may need to expand. At the same time, financial aid is requiring earlier and earlier dates, so last-minute awarding doesn't happen that much anymore. The book-seller will be able to go down to the section level. They are trying to roll this out for Spring 2018.


