Jennifer Lynn called the meeting to order at 3:40 p.m. in the Chancellor's Conference Room.

I. ANNOUNCEMENTS

Nominations are now open for the at-large position on Senate. Congratulations to Vern Gagnon, now Interim Dean of City College.

Also, congratulations to Matt Queen, winner of the ping pong tournament.

II. ACCEPTANCE OF MINUTES

The minutes of December 7 were accepted as presented.

III. PROVOST REPORT

Dr. Eskandari reiterated his commitment to regularly reporting on the Barnes & Noble First Day Complete project. After discussion, it was decided that everyone needs more time, so the implementation (originally Fall 2024) will now be Spring 2025. They plan to hold town hall meetings for faculty to share concerns and ideas, and the B&N staff will be requested to attend those meetings.

The question was raised as to whether the LMS transition to Canvas will happen at the same time as the start of the B&N First Day Complete program. Provost Eskandari responded that the book program does need to integrate with Canvas, so it will happen at the same time and will be seamless.

The next project that will have regular updates is the proposal to have students use just one email. This is common practice at most universities, but we have challenges including the different ways campuses in the MUS have added student email information to Banner. This may also synchronize with the LMS transition.

Provost Eskandari noted that the new School District #2 Superintendent, Erwin Garcia, has plans to start an early college charter school. The details are not yet worked out, but we plan to reach out to other states that have successfully implemented such a charter school. Such programs allow a freshman in high school to commit to a program that will earn them both a high school diploma and an associate degree at the same time. Details like when are they a high school student and when are they an MSUB student (especially in terms of conduct), costs of the program, and even MSUB faculty needing a Class 8 license to teach high school students will need to be clarified. The Commissioner of Higher Education thinks that the Board of Regents will likely need to approve this project.

Sue Balter-Reitz, Director of Online Initiatives for OCHE, stated that the current LMS transition plan will have faculty teaching in Canvas fully in Summer 2025. However, we will have access and faculty can begin planning courses in Canvas in Spring 2025. In Fall 2024, K16 will begin moving courses from D2L to Canvas. The Center for Teaching and Learning is gearing up for many training sessions on everything associated with this project. The MUS has budgeted for special handling by K16 to move all courses in D2L in the last three years *that have content*, not just a syllabus, but each campus team is telling K16 what courses to transfer.

Dr. Balter-Reitz also noted that applications for the MUS Teaching Scholars are open. This year's theme is "AI in the Classroom." Each application requires a letter of recommendation from the Chair, Dean, or Provost.

Finally, Dr. Eskandari congratulated Eileen Wright as the new Director of the Library, and thanked Vern Gagnon for his service as Interim Dean.
