Mark Jacobson called the meeting to order at 4:00 p.m. on Wednesday, October 28, 2008, in the Missouri room of the SUB.

David Weiss, Department of Communication & Theatre, stated they are adding this new course as a prerequisite for all 300- and 400-level courses in the Department. Students are often not ready for the upper level classes, so this new course will introduce the field and teach them some basic skills. The full-time faculty will teach this course on a rotating basis offered three times a year (fall, spring, and summer), as well as online and on site. COMT 200 will bookend with the current capstone course, COMT 470 Capstone Project.

Dr. Weiss stated that these changes only add COMT 200 to the programs as a required course, and remove COMT 201 Technology for Communication. COMT 201 will not be deleted from the catalog, but it has become unnecessary for the major. COMT 201 will be offered either annually or every other year; it has not yet been decided.

Dr. Weiss noted that in addition to removing COMT 201 and adding COMT 200, students will also choose two of three from COMT 425, 440, and 461 (Media Criticism, Popular Culture and Cultural Studies, and Multicultural Mass Communication, respectively) instead of taking all three. The Department has difficulty offering all of the three courses often enough for students to take them in order to graduate. Also, an unanticipated problem as occurred with the graduate students. Students who have earned their Bachelor's in Communication from MSUB have already taken many of the 400/500 level crosslisted courses, and thus have difficulty getting enough credits for their Master's degree. This change should help alleviate that problem.

Tami Haaland, Department of English & Philosophy, stated this change updates ENGL 324. Gary Acton noted that English & Philosophy takes a studio approach to creative writing courses, so students taking 324 and 424 will be in the same classroom. No new staff will be needed.

Tami Haaland, Director of the Honors Program, noted that these courses will give students the opportunity for intensive field work and research as well as another way to complete the 21 credits required for the program. In the 400-level course, students will be encouraged to publish.

Mark Jacobson, Math Department, noted that this is a Bozeman course to be offered online with the on site lab offered here at MSUB. This is part of an effort to beef up our preengineering program and is also a pilot project from and paid for by the Montana University System. A faculty member at Bozeman will teach three credits of lecture online, and the lab will be taught by Dr. Jacobson. Equipment for the lab is coming from Bozeman and should arrive in a few weeks. The details of who gets the FTE and how students' grades will be integrated are still being worked out, due to the fact that Bozeman offers their lecture/lab courses as 4 credits rather than 3 and 1 like MSUB. The course will be crosslisted with the MSUB physics rubric and offered this spring.

Dr. Jacobson noted that to get around the paperwork needed for a course fee, the students will buy a kit for the lab at the bookstore. It was noted that the form should not indicate that there is a lab fee. The form was altered so no lab fees are listed.

Connie Landis, Chair of the Art Department, stated that they changed the title of ART 499 (Item 16.j) which necessitated the program changes. They are also updating course descriptions and including references to course fees which have been charged all along.

It was suggested that perhaps other courses have fees which are also not listed in the course descriptions. Perhaps the UCC should call for a verification of all course fees in course descriptions.

Dr. Landis noted that the Items not on today's agenda include adding "modern and post modern" to the course description of ART 101, as well as EDCI 305 and 315. There was some debate among the Art faculty about including the phrase.

The Committee agreed to meet again in two weeks.
