Rich Pierce, Chair, called the meeting to order at 4:02 p.m. in the Chancellor's Conference Room.

The November 13 meeting minutes were accepted as presented.

I. ITEMS – FIRST READING

Item 27 REC 494 Seminar. New course.

Item 34 REC 255 Rock Craft I. Change title to Rock Climbing I. Item 34.a REC 257 Rock Craft II. Change title to Rock Climbing II and change course description.

- Motion by Carl Castles, seconded by John Hoover to approve Items 27, 34, and 34.a on first reading.

Lynne Fitzgerald, Department of Health and Human Performance, stated that the seminar course was missed in the CCN process. The titles of REC 255 and 257 are being changed due to confusion with the old school terminology, "rock craft."

Item 37 MART 260 Computer Presentation and Animation. Remove prerequisites.

It was noted that the prerequisite for MART 260 is being removed because east campus students wanting to take MART 260 do not have the prerequisite course. The prerequisites for DDSN 116 are out of date and also need to be removed.

Item 39 ECP 200 Transition to Paramedic Care. Change credits from 1 to 3. **Item 39.a** AAS in Paramedic. Modification to an existing program.

David Gurchiek, Chair, Department of Nursing, Health and Safety Occupations, stated that when ECP 200 was first proposed, it should have been a three credit class. The course has the rigor of a three credit class, but the students' work is not reflected in the credits awarded. The students must do well in ECP 200 to get into the Paramedic program. Dr. Gurchiek noted that Flat Head Valley Community College offers the same course at two credits, so we are within Common Course Numbering guidelines of one credit difference.

Susan Gregory, Department of Educational Theory and Practice, stated that when the special education student teaching course got FLOCed, "student teaching" was removed from the title. "Student teaching" needs to be in the title for licensure, so Item 45 adds it back. The program changes just update the program with the new course title.
