Cindy Dell called the meeting to order at 4:02 p.m. in the South Conference Room of the City College Health Science building.

The April 3 meeting minutes were accepted as presented.

### I. ITEMS – FIRST READING

**Item 56** BMGT 235 Management. Remove prerequisite.

- Motion by Brian Gurney, seconded by Richard Pierce to **approve Item 56 on first reading.**

It was noted that this course is a part of the Associate of Science business programs at City College. The prerequisite, CAPP 120, does not really fit into those programs, so removing it makes sense.

**Item 57** AAS in Radiologic Technology. Modification to an existing program.

**Item 57.a** AHXR 150 Radiological Technology I. Change credits from 2 to 3 and change course description.

**Item 57.b** AHXR 160 Radiological Technology II. Change credits from 3 to 4, change prerequisite and corequisite, and change course description.

**Item 57.c** AHXR 180 Radiological Technology III. Delete course.

**Item 57.d** AHXR 195C Radiographic Clinical III. Change credits from 8 to 9 and change prerequisite and corequisite.

**Item 57.e** AHXR 250 Radiological Technology IV. Change title to Radiologic Technology III, change credits from 3 to 4, change prerequisite and corequisite, and change course description.

**Item 57.f** AHXR 260 Radiological Technology V. Change title to Radiologic Technology IV, change credits from 3 to 2, change prerequisite and Corequisite, and change course description.

**Item 57.g** AHXR 270 Radiographic Registry Review. Change credits from 3 to 2 and change prerequisite.

- Motion by Brian Gurney, seconded by Richard Pierce to **approve Items 57 through 57.g on first reading.**

Mick Ender, Radiologic Technology Program Manager, stated that these changes move the lecture courses earlier in the program and combine some content. They discovered they don't need quite so many hours to complete the program. The credits for AHXR 270 (Item 57.g) are reduced to two, in line with other Rad Tech programs in the state. STAT 141 is being removed as math choice, because they want Rad Tech students to have strong basic math skills. They also accept college-level algebra or higher.

**Item 54.g** BA Major in Art. Modification to an existing program.

**Item 54.h** BFA Major in Art. Modification to an existing program.

**Item 54.i** BA Major in Art Teacher Licensure Option. Modification to an existing program.

**Item 54.j** Teaching Minor in Art (K-12). Modification to an existing program.

**Item 54.k** ARTZ 406 Gallery Professional Practices. New course.

It was noted that Items 54.i and 54.j have not yet been approved by the College of Education Curriculum Council, so they will be held for UCC approval for now.

- Motion by Brian Gurney, seconded by Carl Castles to **approve Items 54 through 54.h and 54.k on first reading.**

Patricia Vettel-Becker, Chair of Art, apologized for the lateness of these proposals, which are in response to their accreditation visit. The report from that visit was received in January.

Dr. Vettel-Becker noted that they are deleting the watercolor courses and folding that content into the other painting courses. This is because the faculty member who taught watercolors is retiring, and this is also an effort to reduce and eventually eliminate the Art Department's "stacked" courses. Currently, many of their courses are taught with 100-, 200-, and 300-level students all in the same

classroom. They are trying to simplify their courses so fewer have to be stacked. ARTZ 400 is being deleted and the career material will be covered in ARTZ 409. ARTZ 409 also prepares students for the capstone course. The B.A. programs and the B.F.A. reflect these changes. They have also changed the B.F.A. to require all 200-level studio courses and added the new course ARTZ 406, which is a specialty of a new faculty member. The Teaching Minor is increasing from 26 to 30 credits to add more content, since it is a K-12 minor. Staff are in place for all new courses.
