Jay Gentry, English, Philosophy & Modern Languages, noted they are streamlining the English major. The Department has had multiple faculty retire in the last couple years. Students were struggling to get the courses they needed, because so many course choices fell under one requirement, students ended up dispersed across several that then were cancelled for low enrollment. They have had to offer multiple independent studies in order to get students graduated. The faculty have developed a plan of study that works no matter when a student starts, Fall or Spring. At least two faculty can teach each course, so there is backup.

It was noted that several courses have been removed as requirements in the program, and new courses are being added. Are any courses being deleted? Dr. Gentry responded that they were unsure about deleting courses, but will follow up and do so.

The Department is in the process of updating their course learning outcomes. Once those are complete, they will then review their program learning outcomes.

There are no changes to the teaching major at this time.
