Sam Boerboom, Chair of Communication, noted that all of these courses meet the criteria in the policy: the titles are the same, the credits are the same, the course descriptions all state the course may be co-convened, and all have additional requirements for graduate students. Some of the learning outcomes are separate and unique for grad students, while others have the undergraduate learning outcomes nested in the graduate outcomes. Since most of the Communication curriculum is in co-convened courses, the Department agreed to add a statement to all syllabi that graduate students have a higher standard for their work.

It was noted that one of the outcomes for COMT 502 starts with the verb "choose," which is probably not a good idea. It will be revised.

It was noted to be sure that grad students are not teaching undergrad students in these coconvened courses.
